BMW Planning Full Diesel Lineup

from *Roundel Weekly*, November 13, 2012

America may be short on diesel-powered cars now, but BMW appears ready to fix that. Leaked plans suggest that the company is launching diesel engines across its entire lineup, starting with the 3-Series sedan in spring 2013, followed by the 3 Series sport wagon later in the year. The BMW 5-Series sedan will also get a diesel engine, as will the X5 (which is already available in a diesel version). In 2014, the 7-Series and the X3 will receive



diesel engines as well, filling out the lineup.

The engines coming to the U.S. include a two-liter four-cylinder turbodiesel, and a three-liter six-cylinder turbodiesel. The four-cylinder diesel will make 180 horsepower and 280 pound-feet of torque, while the inline six will offer 265 horsepower and 425 pound feet—while returning between 30 and 40 mpg on the highway.

BMW Building New 2-man Sled for USBSF

The ultimate sliding machine may be on its way to the U.S. Bobsled and Skeleton Federation.

BMW of North America announced Wednesday that it has been working with the USBSF to develop a new two-man bobsled, with an eye on having it ready for the 2014 Sochi Olympics. The deal has been in the works for more than a year — a prototype has already been delivered — and the U.S. believes it could be a major boost to medal hopes.

“I happen to think these are going to be very good,” USBSF CEO Darrin Steele told The Associated Press.

The U.S. won Olympic gold in women’s bobsleding in 2002 and a four-man gold in 2010, but the two-man gold has eluded the Americans since 1936.

BMW Group also has a sponsorship arrangement with the U.S. Olympic Committee through the 2016 Rio de Janeiro Olympics, and the company also is the official mobility partner for the USBSF, U.S. Speedskating, USA Swimming and USA Track & Field. BMW’s talks about this project with the USBSF go back to at least March 2011, with the sides exchanging ideas about how the technology of building fast cars can translate into building fast sleds.

“They’ve helped us think outside the box on what they can do to extend the sponsorship past cash and tap into what they do really well, and that’s technology and high-performance,” Steele said. “They took a chance with this.”

Bobsleds are much like race cars — there’s very specific rules about how to build them, and to the naked eye, most seem identical.

If this goes the way BMW and the USBSF would

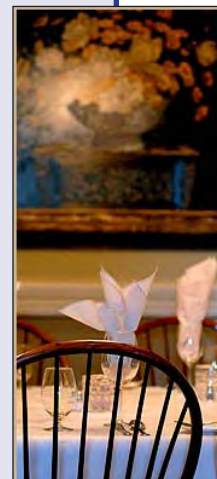

Changes to Chapter By-laws Proposed

Must Be Approved by General Membership

As reported last month, the Badger Bimmers' Board of Directors would like to make the Liaison positions in the Madison and Fox Valley regions voting members of the Board. By doing this, more of the state will have representation on the Board, and the Board will be better able to promote the objectives of the Club in sharing good will and fellowship and offering more social events in these areas.

Expanding the Board of Directors requires amending the Chapter's by-laws. The Chapter membership must be notified of any proposed amendments and given an opportunity to approve or disapprove their adoption.

This year's election ballot (page 9) invites you to vote whether to adopt or reject this amendment of the Badger Bimmers' by-laws, as well as other clarifications of officers' responsibilities.

The affected sections of the by-laws are presented on these two pages, with the new or changed wording in boldface type.

Please read and consider these changes carefully, then use the ballot provided to cast your vote.

E. The Board of Directors shall consist of **eleven** active members. This shall include the four officers as listed in Article VI, Section 1 plus four members elected at large and **one liaison each from the Madison and Fox Valley areas**. The **eleventh** position is to be filled by the immediate past president or in the absence of an immediate past president, by a fifth elected officer. At a meeting of the Board of Directors, **six (6)** of the Board being present **or on conference call** will constitute a quorum.

F. The Board of Directors shall be elected in alternating years as follows:

On each odd year, elections will be held for President, Treasurer and two board members **and the Madison liaison**. Additionally, a 5th officer will be elected for one year if the immediate past President is absent.

On each even year, elections will be held for Vice-President, Secretary, two board members **and the Fox Valley liaison**. Additionally, a 5th officer will be elected for one year if the immediate past President is absent.

ARTICLE VIII DUTIES OF OFFICERS

Section 1: DUTIES OF PRESIDENT

The President shall preside at all meetings of the members and the Board of Directors and shall perform the duties usually appertaining to his/her office. S/he may call special meetings of the membership upon fifteen days notice in writing to each member. S/he shall be the chief executive officer of the Club. In the absence of the President, or in the event of his death, resignation, disability or disqualification, his duties shall be performed by the Vice President. **The President shall represent the Badger Bimmers Chapter at all national/regional conferences. S/he will also communicate to the members in each newsletter published.**

Section 2: DUTIES OF THE VICE PRESIDENT

The Vice President shall assist the President in the conduct of the administrative affairs of the Club and perform such other duties as may be assigned him/her by the President or the Board of Directors. The Vice President shall stand first in succession in the event of the President's death, resignation, disability or disqualification. **The Vice President shall be in charge of all insurance matters for the Badger Bimmer Chapter's social and driving events. S/he will be responsible for obtaining the necessary certificates for each event.**

Section 3: DUTIES OF THE SECRETARY

The Secretary shall attend all meetings of the members and Board of Directors, and shall report full and complete minutes of the proceedings and votes in books meant for that purpose. The Secretary shall have custody of the Club's records. In the event of the Secretary's death, resignation, disability, or disqualification, the Board of Directors may appoint a successor. **Approved minutes will be submitted to the webmaster for publishing.**

Section 4: DUTIES OF THE TREASURER

The Treasurer shall have custody of all money and assets belonging to the Club. He shall receive all monies of the Club and deposit them to the Club's account in a bank designated by the Board of Directors. S/he shall have direct control over supervision of all Club assets and of all payments of all Club debts and obligations. S/he shall insure strict compliance with these By-laws in all matters pertaining to the financial affairs of the Club.

The Treasurer shall maintain accurate books of the account which shall properly reflect the true and correct financial status of receipts, disbursements, balances, assets and liabilities of the Club. **The treasurer will fulfill all tax obligations and filings on time and report such to the national office when due.** All checks or other orders for the payment of monies in the name of the Club shall be signed by the Treasurer and by such other Officer or Officers as may be designated from time to time by resolution adopted by the Board of Directors. In the event of the death, resignation, disability, or disqualification of the Treasurer, the Board of Directors shall appoint a successor to complete his/her term.

Section 5: FURTHER DUTIES

It shall be the further duty of all members of the Board of Directors to keep in constant contact with the National Secretary to maintain liaison with other BMW Clubs in the United States and abroad.

All board members and officers will write two articles for the *Bimmer Immer* each year.

The Madison and Fox Valley liaisons will be voting members of the Board of Directors. Each is responsible for organizing one chapter board meeting per year in their respective locations. The Madison area board meeting will be held in March and the Fox Valley area board meeting will be in October unless otherwise changed by the Board of Directors. Each liaison will also organize a spring clean-up and other activities for club members in their respective areas.

ARTICLE XI MEETINGS OF THE BOARD OF DIRECTORS

Section 4: QUORUM

Six (6) Board members present **or on conference call** at any meeting shall constitute a quorum for the transaction of business.

ARTICLE XII AMENDMENT OF BY-LAWS

Section 3: NOTICE OF PROPOSED AMENDMENTS AND REFERENDUM

The Board of Directors shall notify the membership by mail, **published in the *Immer* or email** of the proposed amendments, together with an explanation of the amendment and the need therefore by its sponsors.

Explanation: The Badger Bimmers Board of Directors would like to make the Liaison positions in the Madison and Fox Valley regions voting members of the board. In doing this more of the state will have representation on the board and better be able to promote the objectives of the club in sharing good will and fellowship and offering more social events in these areas.

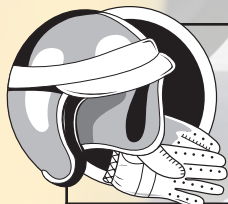

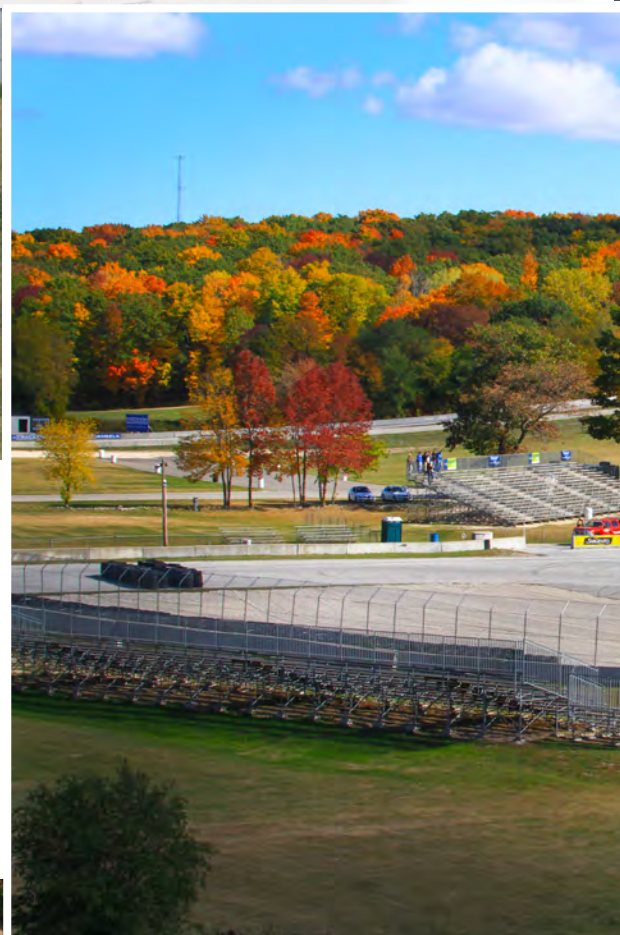

Bimmer in the Barn

Part 8

Work on the Bimmer in the Barn has now shifted to the back of the car. I mentioned in an earlier article that the rear of the car had been damaged sometime early in its original owner's history. The car was repaired, but this meant repairs by late 1970s' or 80s' standards, and this was clearly not going to cut it.

As I've said before, I'm going to do this job only once.

The scary part is that, by the time you remove all the offending parts, what you have left is something that loosely resembles road kill that has been picked over by vultures. This is all going to take some time. And, by the way, the same undercoating that was used in the engine compartment was also used to coat the trunk compartment, oh goody!



Rear Damage Extensive

The early damage involved the rear body panel, the trunk floor, and both rear quarter-panels. The problem is that the rear panel and quarter-panels were repaired by splicing parts of new panels in place of the damaged ones. This was an acceptable repair back in the day, but this repair meant that large amounts of filler had to be used to finish the spliced areas, and the areas that weren't replaced, needed lots of filler to finish them. An older repair like that also brought a good possibility, that areas replaced were welded by brazing as opposed to mig or tig welding.

Sooo, how do you fix this mess? A proper fix would involve replacing all the damaged parts in question. Now, fortunately I've been collecting parts for a project like this for a while, as I mentioned before. This is work that I've done enough times that it's almost more muscle memory than thought.

The Powers That Be

Remember that clutch slave cylinder that would not give up its hold on the transmission? Well, I conquered that one, but you have to be amazed at the adhesive powers of corrosion. The bad combination of pot



metal cylinder and aluminum transmission housing doesn't help the equation. I quite literally had to cut the slave cylinder into pieces, and then chisel the remaining bits out of the transmission housing.

The irony involved here is that the same corrosive powers that welded that piece into the transmission, are the same ones that work to gobble up all that lovely German sheet metal — quite a formidable opponent.

So a lot of work ahead. But I'll keep chipping away at it (okay some pun intended).

like, this new two-man sled would be different, with both sides saying the look is unique.

"What we've got so far, it is recognizably different," said Michael Scully, a creative director for global design at BMW. "It can be what bobsleds in the future are identified as, or it can come to define



something that doesn't work. We're really in the early stages of testing. What we're working on is still in development, but yes, it is distinctively recognizable."

BMW is headquartered in Germany — a huge bobsled rival for the U.S., and a nation that typically produces some of the best sliders in the world.

The irony of this arrangement has not been lost on anyone involved.

"It is going to be interesting," Steele said. "They're sponsored as well, but this one is going to be a little bit different."

Some U.S. drivers, including reigning Olympic and world champion Steven Holcomb, tested the prototype sled on the 2002 Olympic track in Park City, Utah, earlier this year. There's been no announcement about when the sled would make a competitive debut later this season in a World Cup race; this weekend's stop on that circuit is in Park City.

Scully did not know much about bobsledding when his role with the project began, though he had a background that made him perfectly suited for the role. He's an accomplished athlete, both in auto racing and alpine sports — combine them, and essentially, you have bobsledding.

He's even taken a run down the track in Lake Placid, N.Y., thinking at the time he'd be able to snap pictures and enjoy a smooth ride. One turn

into that trip, he dropped the camera into the sled and began hoping merely to survive the intensely bumpy ride.

"I got exposed to something at the bobsled track I wished I'd gotten exposed to 25 years earlier," Scully said. "It's the coolest thing I've ever seen. It's such a wonderful sport."

"This whole project is about delivering the fastest tool that we can deliver to the athletes," Scully said. "It really is about us trying to provide them with the very best equipment."

BMW says its "EfficientDynamics" technology that works for cars is being applied to the sled plan, with lightweight materials, "optimized aerodynamics and chassis dynamics," and all of it being done to increase "overall sport performance."

"We're no strangers to sport performance characteristics such as agility, speed and aerodynamics," said Ludwig Willisch, the president and chief executive officer for BMW of North America. "To be involved in a project with opportunity for such direct transfer of our core competencies to the advancement of Team USA was a very exciting proposition for us. We can't wait to see this finished sled on the ice."
