The club finished 2005 with a net revenue of \$5,190,033 and a surplus of \$102,199. The club has assets of \$3,209,795 principally comprising of cash and the National Office. The member's equity is 927,484.86.

As the Treasurer has reported, the Club is in good financial shape. I can report that over the past year, the Board has been deliberate in considering and authorizing the budget and one of our primary tenets remains to exercise good stewardship of the members' money. Going forward, I see the Board continuing along that same path. Within that principle, I would look to the Club to expend funds to continue supporting the chapters, support our charitable giving program, keep Roundel magazine the best car cub magazine in the world, and develop and execute a marketing plan that will allow us to better compete to recruit and retain members in a society that continuously offers potential club members more and more choices to spend their money and choose the groups with which they affiliate. I look to reasonable expenditure of funds to continue to develop our web site, to make it reach, sooner rather than later, it's potential as the information and entertainment resource it can be, and that it become a major reason why people look into, join, and remain in the club.

I look for a reasoned and well-planned approach to attracting different groups of BMW enthusiasts to affiliate with, associate with, and interact with BMW CCA and our chapters. I believe we have an obligation to all our members to give them the opportunities and the flexibility to express their enthusiasm for the marque and their participation in the club; that we have to seek a balance between maintaining the traditions that have made us a great club, and the realities that a changing consumer and enthusiast base present us.
