4. Reports:

4.1. President.

Mark Jon Calabrese reported that Scott Blazey indicated that he had nothing to add to his pre-meeting report.

4.2. Executive Vice President.

Mark Jon Calabrese had nothing to add to his pre-meeting report.

4.3. Secretary:

Bruce Hazard had nothing to add to his pre-meeting report.

4.4. Treasurer.

Louis Goldsman reported that were no changes to his pre-meeting report.

4.5. Pacific RVP:

Eddy Funahashi added that the Sonora Chapter is up and functioning with 75 members. The Las Vegas Chapter is working well with the Chapter.

4.6. South Central RVP:

Fred lacino had nothing to add to his pre-meeting report.

4.7. North Central RVP:

Len Mueller added that chapters in the North Central Region are experiencing reduced registration at their driving schools.

4.8. South Atlantic RVP:

Carlos Diaz-Estrada had nothing to add to his pre-meeting report.

4.9. North Atlantic RVP:

John Sullivan had nothing to add to his pre-meeting report.

4.10. Executive Director.

Wynne Smith had nothing to add to her pre-meeting report.

4.11. Club Racing:

There was nothing to add to Dave McIntyre's Club Racing pre-meeting report.

4.12. DEC:

Bill Wade had nothing to add to his pre-meeting report.

4.13. Roundel:

Phil Marx and Satch Carlson had nothing to add to their pre-meeting reports. Phil reiterated that advertising is down about 10% as was discussed at the last Board meeting.

4.14. bmwcca.org:

Bill Howard provided an update on the website. The highlights are:

- Yesterday the web staff and contributors had a productive meeting.
- A database of photos is being considered for use on the web and by others.
- The big project currently is the redesign which is still planned for completion by the end of the first half of the year.
- The big challenge is the archiving of full versions of the Roundel. The search is still on for the right software at the right cost. When implemented issues as far back as 1996 could be available on line.
- Satch observed that the Roundel needs to be more prominently displayed on the website.
- The website articles will tease upcoming Roundel's articles.
- Michael Slaff is working on advertising packages that would include both print and online ads. The goal is to stabilize total advertising even though at any given time one could go up as the other goes down.
- Online version of TechTalk is progressing and will provide multiple staff answering the questions.
- Publishing criteria for web articles is:
 - o Is it of interest to many members.
 - Will err on the side of inclusion.
 - o It has links to chapter sites.

4.15. BMW NA:

Larry Koch made the following comments:

- The web site is important, 90-92% of their buyers look at their website before purchasing a BMW.
- The trend at BMW NA is the same as others companies who are spending less on print advertising and opting for more online exposure. However, print is not going away, there is still a place and benefit to magazines and brochures.
- The average age of the current BMW buyer is 45.
- Industry wide:

- The enthusiast is a shrinking portion of the total car owners which is increasing.
- Therefore, don't get stuck catering to the enthusiast.
- BMW is the 7 or 8th largest selling manufacturer in the US with 300K new sales, 100K Certified Pre-Owned, and 45-50K Mini's.
- The International Council has approved new logo standards. Details will be announced when available.

5. **Discussion Topics**:

5.1. National Events:

5.1.1 TechFest 2007:

- There are 193 registrants.
- Vendors seem happy and sponsors are interested in Oktoberfest.

5.1.2 TechFest 2008:

- The Nittany Bimmer Chapter has contacted the National office and expressed interest in participating in a TechFest.
- There was a discussion about how frequently TechFest should be held and the format. An option that was discussed was to hold a day of classrooms followed by a day of vendors and demo's at a track.
- Also discussed was an option to combine TechFest with Oktoberfest by adding a day of technical sessions.
- It was proposed to skip 2008 and study the format.

5.1.3 *Oktoberfest 2007:*

- Larry Koch mentioned that this year the test drive cars will be models that are not available at the dealers, i.e. diesel, etc.
- Speakers are being finalized including Steve Soper, a renowned E30
 M3 racer and BMW Dealer in England.
- Sponsors are falling into place with the return of Bridgestone and possible addition of Griots as well as a number of local merchants.
- The registration will open in April.

5.1.4 Chapter Congress:

• Planning is in the final phase, speakers are lined up.

5.1.5 Future National Events:

Newsletter and Webmaster Congress is planned for May 2008.

5.2. National Programs and Services:

5.2.1 Website

- The development of registration forms to populate the iMIS database is basically completed; however, there seems to be a security issue in iMIS system that is preventing the population. If this can't be resolved other alternatives will need to be investigated.
- The beta site for the redesigned website should be available in 30 days.
- Bill Howard stated that development of a revenue plan for the website will be a project for the second half of the year.

5.2.2 Club Racing:

- Louis Goldsman noted that the National Appeals committee has concluded their review of the appeal regarding Club Racing Chairman's actions regarding the appeal of a 13/13 penalty. The parties will be notified on Monday the 29th.
- Sponsorship is healthy and growing.

5.3. Financial:

- 5.3.1 2007 P&L to date thru February shows a net loss of \$47,274.70
- 5.3.2 The final 2006 P&L was a loss of \$133,142.65 as compared to a budgeted loss of \$171,000.

5.4. Chapter Issues:

- 5.4.1 There are few chapters that are close to going on probation and are working with their RVP to prevent probation.
- 5.4.2 The New Chapter officer education and information resource is on the website and continually expanding as topics are identified.
- 5.4.3 To provide continuity between the outgoing and new Board member, it was recommended, and unanimously agreed, that it would be beneficial for the new Board member to participate in the conference calls between election and the Annual meeting.
- 5.4.4 It was also agreed that a checklist of issues and do's and don'ts would be helpful for use as new Board member orientation. It was agreed that the new Board members, Paul Dunlevy and Mike Mills will develop this document based on their experience.
- 5.4.5 Chapters wanting to obtain flags or banners can contact the National office for sources and group purchases.
- 5.4.6 Carlos Diaz-Estrada reported that there is an Internet group in Central Florida that wants to form a chapter. They are being encouraged to get involved with the local chapter but as yet what they want to do does not fit in with the events held by the local chapter.

5.5. Regional Events:

- 5.5.1 The website will customize the Calendar of Events for a member based on the events in their local and regional area.
- 5.5.2 There was a discussion about providing promotion on the website in addition to the ad provided in the Roundel.

MOTION: Carlos Diaz Estrada made a motion that in addition to the Roundel ad, events being awarded Regional status also be provided promotion on the BMW CCA website. The motion was seconded by Fred Iacino. IN FAVOR: All present. ABSENT: Scott Blazey.

5.6. Membership and Administration:

5.6.1 After a brief discussion, it was agreed that the Z4 Coupe would be a good choice for this years raffle because of price and general appeal should sell tickets.

5.7. Future Oktoberfests:

- There was a discussion of the recommendations presented by the Oktoberfest Committee at the January Board meeting. In summary they were:
 - o Intensify and maximize the promotion and advertising for the event.
 - o Implement site selection criteria and a selection committee.
 - Implement a set rotation through the five BMW CCA regions.
 - o Maintain the five-day format but shift it to Tuesday thru Saturday.
 - o Implement a five-year planning schedule.
 - Develop a systematic approach to evaluating each event.
 - Do not make radical event format changes until a promotional job is accomplished and evaluated.
- Wynne Smith felt that surveys indicated a majority request for a shorter event.
- Bruce Hazard pointed out that surveys and comments showed diverse opinions. Some members wanted only motorsport events, others were interested in social only; some wanted a 3 day event, others liked the 5 day schedule; some liked the weekdays, others wanted more weekends and less time off work.

The current format provides some level of compromise for all these groups: Motorsports only package (driving school and autocross, Tuesday – Thursday), social only package (Thursday thru Saturday) or everything. These can be sold separately or as one package.

- The suggestion was repeated to incorporate a day for TechFest and see how it works.
- Several members pointed out that we needed to decide on a plan, make the changes and implement them.

MOTION: Len Meuller made a motion to accept the Oktoberfest Committee's recommendations plus work in the TechFest sessions as a combined event in 2008. The motion was seconded by Fred Iacino. IN FAVOR: All present. ABSENT: Scott Blazey

MEMBERSHIP CONTEST

Accomplishments:

- **CR Office.** The BMW Club Racing office moved from Fran Hughes' house to the BMW CCA National Office. Tricia Williams has been doing an absolutely fantastic job learning all the details that go into running our program, and has been handling almost all racer customer service issues. Fran continues to evaluate new license applications for us. Thanks to Fran and Tricia!
- PA Region CRAC Elections. Due to some internal CRAC unpleasantness, Xavier McClure stepped down as PA Region CRAC rep. We appointed Jon Holder as Xavier's replacement, with Eddy's approval as required.
- **2006 Champions** were computed, and Points Steward Steve Ayers is ordering the trophies.

Issues:

- Rules. The rules clarification process has been running wonderfully. All four members have voted on all issues, and we have published 31 clarifications so far in 2007 (13 of which were incorporated into the 1/23/07 version of the rules).
 - National Protests. One protest continues:
 - Steve Ayers protested the actions of Comp Steward Bud Merrill and Tech Steward Marty Howes at the Roebling Road race in December. His protest was upheld, and another racer received a 3-lap penalty for a pit lane violation and a 13/13 penalty for intentionally misleading a steward. Randy Mueller protested this appeal to the BMW CCA National Board, and an appeals committee was formed. As of 3/13/07 I have not received official notification of their decision.
- **2007 Schedule.** Bruce Lummis is managing our schedule for the 2007 season with 31 races as of this report.
- .• Stewarding Expenses. We continue to get pushback on steward expenses. At the same time, we plan to increase the number of stewards at many events. An expense responsibilities summary sheet will be added to our sanctioning application and will require an event chairman signature.

Event Issues:

- Sebring/PBOC. Typical low turnout event, but no problems. No incidents.
- .• CMP. Well-run event, no problems. No incidents.
- **PIR**. Well-run event with a single one-car incident leading to a 3 month 13/13 probation penalty. There is an issue with the insurance certificate for this

event; we are trying to figure out if it was suitable.

Sponsors:

- New Sponsor: VT Motorsport. VT Motorsport signed an agreement to be an associate sponsor of BMW Club Racing on 1/6/07.
- Two More Sponsors. I am still in final negotiations with two more Premier-level sponsors; I expect both to be announced in late March.

Roundel Managing Editor's Pre-Meeting Report

Publication:

The April issue will be complete and at the printer by the time we meet. It will contain 152 pages plus covers, and nine feature articles.

Advertising Revenue:

For the February 2007 issue, ad billing is down about 10% compared to 2006 with a 16% decrease in ad pages YTD compared to 2006 (seventeen pages over two issues). Ad billing is down 12% YDT.

The 144-page February issue maintained a reasonable 35% ad-versus-editorial content. Our selfimposed limit is 40% ad pages. I hope to have up-to-date figures for you by meeting time when MIchael Slaff, Roundel ad manager, recovers from a computer issue.

Considering that our issue size is somewhat ad-driven, a comparison might give this a better frame of reference: Our average page count for the year 2006 was 152, and for the first four issues of 2006 that number was 148. YTD 2007 the figure is 144, including the April issue, which is actually the size we commonly use for budget purposes.

Editorial Calendar:

The most recent monthly update to the editorial calendar from the editor-in-chief is included as received in an Excel attachment to this report. The editor-in-chief should be able to supply an updated version at the board meeting once the post-February-issue shuffle is complete. The editor-in-chief will attend the meeting, as requested, but has declined to provide a separate report.

Production Costs:

Our actual per-copy printing cost for the February issue was lower than average including one TechFest registration page. For comparison, a similar-size June '06 issue containing a two-page O'fest registration carried a highter per-copy cost.

Financial:

Roundel staff submitted a slimmed-down budget proposal for 2007 to the treasurer and the executive director, as requested. I have not vet received information showing how we are performing compared to that budget or what budget numbers were approved for 2007, however, I am confident we are operating within our proposed figures.

Club Website and Roundel:

Satch, Bill, and I have been in discussion concerning cooperation between Roundel and BMWCCA.org as the Web editor-in-chief moves forward with the Clubs online presence. We will continue this cooperation to enhance the Web site in addition to expanding Roundel features and services on the Web.

As always, we continue to feel Roundel is fulfilling its mission to inform, entertain, and provide a sense of



Meanwhile, site traffic grows in response to more stories being posted. We need to make better progress on integrating our member database with a signup/registration module.


Site traffic gains

bmwcca.org site hits continue to grow. From September through January were in the high teens – to 2,000 visitors per day. most weekdays we're over hits per day. We had record early March, topping 2,700. surprisingly, we get the most when we have the most new material posted. Traffic climbed during our auto coverage (Chicago, Geneva) new model intros (Mini, 3 Series Convertible). We also



more hits when there's news of signups.

Also we're seeing more days higher number of pages viewed per visitor, almost more pages viewed on good This maps to days with lots coverage. The spikes you early February, late February, and early March around the time of car shows, car intros, and coverage of major BMW regional events. We are in posting them, and if we're the first, we're the site with most BMW- and Mini-related information.



Site redesign

Site redesign is still targeting launch within 2007 first half with a fresher look, room for more stories on the home page, and room for advertising. Back-end coding of the site is proceeding while we await a final design (the two are moving in parallel). Site design goals (recap):

- -- Incorporate new look and feel of club logo and slogan ("You Belong Here")
- -- More stories on the home page.
- -- More coverage.
- -- More original coverage.
- -- More coverage from club members
- -- More discussions with discussion and tech forums more prominent on home page.

-- Promote club events and membership while making site attractive to all who visit: event attendees, club members who might attend, club members who might attend last-minute as day trippers, and non-members.

Travel

There has been extensive travel in the new year for original content stories: Detroit, Chicago, Mini launch, 8 Festivals in Florida (van Woerden) and California, Geneva, Daytona (Morgan) and Sebring (van Woerden) races and corrals, 3 Series convertible launch, TechFest, Chapter Congress. This has also been a good opportunity to speak about the club's website.

Chapter Congress

At the Chapter Congress in April, I'll run a session on how to get your chapter's events covered on the site, with a focus on creating worthwhile photo slideshows that would appeal to all club members, not just the participants.

Multimedia on the site

We will record a couple TechFest sessions for audio podcasts. We also hope to do a video interview with Csaba Csere and capture his speech for streaming from the site. This will be a build-up to more extensive efforts at Oktoberfest.

Staff meeting

A half-dozen contributors and site staff were to meet at TechFest to talk about goals and share ideas.

Roundel online

Roundel online remains important once we find right software at right price. The best software is not cheap, especially if costs aren't amortized over lots of users. Most likely users would be: lookup for authors, photographers (clips), those who are subjects of stories, and research of print technical articles. Few members are likely to read Roundel primarily online cover to cover, nor should they, since there's better resolution and it's easier to read in print. Roundel online will be accessible to members or possibly as a pay-per-view. For now, we continue with two stories per month, as PDFs, plus the cover and table of contents, available to all.

We will run some Roundel overmatter online, meaning material that didn't fit in Roundel, so long as it's good material or material that didn't fit in the context of the story. An example: photos with a column since Roundel generally does not to run photos on a column page.

Database, online registration

It remains a challenge to make the iMIS database work with the MotorsportReg signup module. The goal is for all club signups – member renewal, Oktoberfest, Techfest, chapter events and driving schools if the chapters desire – be the same tool and same interface. We need to shortly (this quarter) determine once and for all if they can be made to work, and without compromising security. If they can't coexist, we need to evaluate other solutions.
